

GENERAL RULES & REGULATIONS

	The exhibitor agrees to abide by all rules & regulations and respect any contract, agreement, or collective agreement binding them to the PGA of Alberta and the suppliers for the PGA of Alberta Buying Show. Exhibitors agree to obey the laws of all levels of government and abide by all applicable requirements enforced by the fire department.
2.	A dress code is in effect AT ALL TIMES during the PGA of Alberta Buying Show. THE DRESS CODE IS BUSINESS PROFESSIONAL. Denim of any color (i.e. jeans) is not permitted. Please review the included infographic on the following page for additional details.
5.	Absolutely NO guests of exhibitors will be allowed entry. Only registered exhibitors and attendees are allowed on the show floor. While PGA of Canada members are allowed to bring corporate clients on the show floor during set times as determined by the PGA of Alberta, and identified in the show schedule, this does not apply to exhibitors.



Badge identification must be worn at all times.

No one under the age of 18 will be permitted on the show floor. Photo ID may be requested in situations where age verification is required.



The PGA of Alberta has the right to refuse or prohibit entry to the 2024 PGA of Alberta Buying Show should an exhibitor violate the regulations. Any such violation gives the PGA of Alberta the right to terminate the contract and expel the exhibitor from the premises.

BOOTH RULES & REGULATIONS

Booth space is considered sold once it has been paid for and is sold to an exhibitor at the discretion of the PGA of Alberta alone.

If desired, the PGA of Alberta may change the layout or location of an exhibitor's space up to 10 days before the start of the PGA of Alberta Buying Show. The exhibitor will be informed of any changes.

The exhibitor agrees to use the rented space for their own purposes. **The exhibitor may share the assigned space with another company, but can only be identified as one company name.** The company name the exhibitor registers under is the only name that will appear in the Industry Directory and on the floor plan.

If an exhibitor represents multiple companies and would like each to appear separately in the Industry Directory, and on the floor plan, they must register each company individually.

The PGA of Alberta will consider this when assigning booth locations on the floor plan.

Under no circumstances may an exhibitor begin dismantling their booth before the PGA of **Alberta Buying Show** has closed on Day 3. Should an exhibitor violate this regulation, they will be fined \$750 and receive a written warning. If an exhibitor violates this regulation a second year, the fine will increase to \$1,500 along with a written warning. Should an exhibitor violate this regulation a third year they will be banned from the PGA of **Alberta Buying Show for** a period of 1 year.

BOOTH RULES & REGULATIONS

In preparation for setup at the PGA of Alberta Buying Show, exhibitors must ship their merchandise postage-paid. No one is authorized to accept merchandise requiring payment on delivery.

Global Convention Services is responsible for assistng exhibitors with all shipping logistics, including advance warehouse storage if needed.

Exhibitors agree to comply with regulations respecting the height and signage used in their booth. Booth walls may not exceed 15 feet and signage with company logos and advertising cannot back onto or overhang another exhibitor's booth. Failure to follow these regulations will result in booth modifications by the PGA of Alberta. Move-in must be done through the loading bay doors by booking a time using the Calgary Stampede Voyage Control system. Hand-carrying product through the front doors will not be permitted.

Exhibitors must ensure their booth appears in good condition at all times.

Exhibitors are also responsible for ensuring at least one representative is in the booth at all times while the show floor is open.

After the PGA of Alberta Buying Show closes on Day 3, move-out must be done through the loading bay doors. Exhibitors do not have to book a move-out time using the Voyage Control System in advance. Once an exhibitor is packed and ready for move-out, the Calgary Stampede Concierge will give them a paper with a Voyage Control code to gain access to the loading bay area.

More information related to move-out will be shared with exhibitors on Day 3 at the PGA of Alberta Buying Show.

EXHIBITOR CONTRACT TERMS & CONDITIONS

TERMINATION

The contract may be terminated through written notice sent to the PGA of Alberta at least 30 days before the Buying Show is held. **A sum of \$200.00 will be retained to cover administrative fees.** The balance will be reimbursed to the exhibitor.

Should cancellation come less than 30 days before the show, the exhibitor must assume all costs related to their involvement in the show, including registration.

FIRST-TIME EXHIBITOR SPECIAL: REDUCED FEE & SPACE

This special is only available to companies who have never attended the PGA of Alberta Buying Show in the past.

The exhibitor agrees to abide by the contract terms & conditions as outlined by the PGA of Alberta.

EXHIBITOR LIABILITIES

The PGA of Alberta Buying Show will not be responsible for any products and/or services sold or offered by the exhibitor. **The PGA of Alberta Buying Show will not assume any responsibility for losses or injuries to property or persons, which might be incurred from pilfering, water damage, fire, accident, or any other cause.** The exhibitor is liable for the damage and deterioration caused to the building, the booth, and the merchandise and goods of other exhibitors.

All exhibitors must have commercial general liability insurance of TWO MILLION DOLLARS and are required to submit an insurance certificate or certified copy of the policy.

This certificate must identify "PGA of Alberta" as an additional named insured, but only with respect to your business operations during the PGA of Alberta Buying Show. **The dates coverage is needed for are October 21-24, 2024, as Set-Up Day must be included in addition to all three days of the PGA of Alberta Buying Show.**

Please ensure the location of the PGA of Alberta Buying Show is included in the description of the COI along with the address of the Calgary BMO Centre (20 Roundup Way SE, T2G 2W1).

The exhibitor shall indemnify The PGA of Alberta and its directors, officers and employees, and volunteers from all losses, claims, costs, and liabilities which may arise directly or indirectly, as a result of the granting of this exhibitor license. The exhibitor shall be solely responsible for all acts or omissions due to or caused by any person at any time while occupying the Licensed Area.

Early bird pricing will be in effect until July 2, 2024, at 4:00 pm. Companies must sign up for the PGA of Alberta Buying Show by this date to receive early bird rates. **Payment must be received by this date to secure your booth space with early bird pricing.**

Booth pricing will increase as of 4:00 pm on July 2, 2024, at 4:00 pm.

HOW TO REGISTER

The registration deadline for exhibitors is Friday, September 6, 2024, at 4:00 pm. Payment must be made by this date to secure your booth space at the 2024 PGA of Alberta Buying Show. Exhibitors have the option to pay for their booth by cheque, credit card, e-transfer, or EFT. Please note a 2.4% service fee will be added to payments made by credit card.
